International Safe Communities Conference

Theme: Connecting Communities and Improving the Evidence Base

Every two years, International Safe Communities hosts a conference inviting communities, partners and Support Centres to meet and share best practices. Representatives from the Safe Communities America network attended the 2013 conference, with Donna Stein-Harris representing the Pan-Pacific Safe Communities Network. The conference was held in Merida, Mexico and covered several different issues and strategies.

Palmerston North, Site visit 30/10/13, Population 85,300

In October 2013, the certifying team observed first-hand cross-sectorial collaboration and reach and effectiveness of community safety initiatives occurring in Palmerston North. Particular strengths highlighted during the review process included: the long history and strong commitment from Palmerston North City Council and the NZ Police; the CPTED work completed in The Square; the reach and effectiveness of existing networks throughout the city; the commitment and support of ACC in older adults falls prevention and workplace safety; and the collaborative linkages with both Massey University and the Linton Military Camp.

In addition, at the site visit reviewers noted the comprehensive approach adopted by the Mid Central Health and MSD in their approach with youth; the innovate road safety initiatives; the strong involvement of iwi; the outstanding leadership provided by Police and their proactive approach to community safety; and very importantly how the dedication, commitment and collaboration of all members of the PNSAB further strengthened the application.

WorkSafe New Zealand begins operations

From Monday 16 December, you're going to need to call WorkSafe New Zealand about workplace health and safety matters.

WorkSafe NZ takes over all the workplace health and safety operations of the Health and Safety group of the Ministry of Business, Innovation and Employment. So when you want to check out whether there's an investigation into a workplace accident, or check some statistical information, call WorkSafe and not the MBIE media phone.

WorkSafe NZ signals a new era. With a single-minded focus on workplace health and safety issues, the agency will have high visibility, provide a single point of accountability and play a leadership role in improving New Zealand's health and safety performance. WorkSafe NZ will work collaboratively with employers and employees to embed and promote good workplace health and safety practice, and enforce workplace health and safety regulations. *Read further about [WorkSafe initiatives](#).*



Social Statistics Update

NZ Social Indicators - new web-based tool launched on Nov 26th

The New Zealand social indicators give you useful social statistics from across New Zealand government in one place, so it's easier to find the information you're looking for. You'll find relevant statistics about key social topics. You'll also find the information you'll need to understand the statistics, and links to where you can get more information and other relevant statistics. Explore the most up-to-date data on a range of key New Zealand social statistics.

Find graphs and data tables by domain:

- Health
- Perceived discrimination
- Education
- Labour market
- Standard of living
- Trust and participation in government
- Culture and identity
- Leisure and arts
- Individual safety and security
- Social connections



Each domain is broken down into more specific measures, or indicators. Each indicator has its own page, which includes graphs, downloadable Excel tables, and information about the data.

Supply and Sale Alcohol to Under 18s

From 18 December 2013, new laws for supplying alcohol to under-18s came into effect. It is illegal to supply alcohol to someone under the age of 18 years unless:

- the person supplying the alcohol is the parent or legal guardian and the alcohol is supplied in a responsible manner,
- or the person supplying alcohol has the express consent of the young person's parent or legal guardian and the alcohol is supplied in a responsible manner.
